Please note the following terms & conditions:

- 1) **Non-refundable Tuition Deposit - \$4,500**  
Junior Kindergarten through Grade 12 tuition fees include a non-refundable \$4,500 tuition deposit.
- 2) **One time, non-refundable New Student Administrative Fee - \$3,000**  
Payable upon acceptance into the School for Junior Kindergarten through Grade 12.
- 3) **Non-refundable International Student Fee - \$5,000**  
Non-resident students must pay \$5,000 annually in addition to the tuition fee. In order to be a resident student, parents must be permanent residents of BC and either Canadian citizens, landed immigrants or otherwise lawfully admitted to Canada.
- 4) **Non-qualifying Student Fee - \$3,650**  
Students who do not qualify to receive the student operating grant from the province of BC must pay \$3,650 annually in addition to the tuition fee. In order to qualify for the provincial grant, parents must be permanent residents of BC and either Canadian citizens, landed immigrants or otherwise lawfully admitted to Canada.
- 5) **Late Interest Charges - 1.0%, accrued monthly**  
Late payments will incur an interest charge of 1.0%, accrued monthly on the outstanding balance, commencing on the May 15, 2024 instalment and subsequent instalments.
- 6) **Administration Fees:**
  - NSF Fee - \$25 for the first cheque and \$50 for additional cheques
  - Payment Plan Fee - 2.0% for extended payments
- 7) **Tuition Refund Plan**  
Enrolment in the Tuition Refund Plan is **mandatory** for the four extended payments and optional for the one payment and two payment plans. The tuition refund plan fee is 1.8% of insured tuition fees and is included in the instalment balances.
